Innovation LLP - Lexis Nexis Taxation Awards 2010.

I first met informally with John Messore and Peter Moroz of Innovation LLP in mid-2008 as a result of a personal recommendation. Several ideas were presented by John and Peter and I was very impressed by the professionalism and enthusiasm shown.
